#### **Overview**

First Ship Lease Trust ("FSL Trust" or the "Trust") is a shipowner and a provider of leasing services on a long-term bareboat charter basis to the international shipping industry. The vessels owned by FSL Trust are leased on long-term fixed-rate bareboat charters and short-term time charters.

FSL Trust presently owns a diversified portfolio of 23 modern and high quality ocean-going vessels comprising containerships and a variety of tankers. Of these, 14 vessels are leased to international shipping companies on long-term bareboat charter basis. The remaining nine vessels are employed on short-term time charters, in a pool or in a revenue sharing agreement.

The majority of the Trust's revenue is derived from the rentals received from fixed-rate bareboat charters. The fixed-rate charters provide the Trust with stable and predictable long-term revenue and cash flow while the vessels employed on market-rate related charters expose the Trust to upturn opportunities.

FSL Trust has seen a marked improvement in its performance following the successful initiatives that have been implemented by the new senior management team. The Trust now has a fully deployed portfolio of vessels split between stable bareboat charter revenues and managed shorter term employment in markets with improving fundamentals. The management continues to take further steps to consolidate the position of the Trust and provide a strong platform for future growth.

FSL Trust is listed on the main board of the Singapore Exchange and its ADRs are quoted on International OTCQX.
