Details of these arrangements are set out in the Notes to the Notice of AGM.

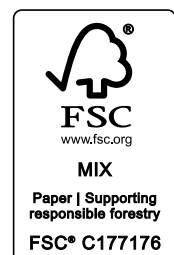
5. **Key dates/deadlines.** In summary, the key dates/deadlines which Unitholders should take note of are set out in the table below:
